Golomt bank financed over 164 projects in wool, cashmere, green house, dairy farming and Sewing industry creating over 1836 new jobs



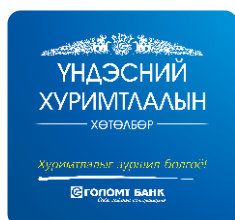
Golomt bank has been selected as the first Mongolian member of United Nation's UNEP Finance Initiative, environmental initiative

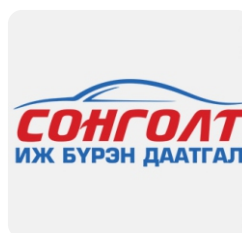
